Mr. Capone discussed the following topics:

- Montague Township School will be expanding the volunteer run extracurricular program from PK to 4th grade to PK to 8th grade.
- Montague Township School will officially offer free full-day preschool for 3 and 4-year olds to residents of Montague. This program will necessitate the hiring for various positions, such as a Director, Teachers, Paraprofessionals and Aides.
- ➤ The May budget was changed because of state aid being cut, plus tuition cost rising from our current send / receive agreements. This is one reason why we look at other choices for our students. Finding other send / receive options will benefit families in the school district in addition to the whole community.

John Mannion, of Chubby Lane, requested to have Mr. John Nittolo come to a Board of Education meeting to speak publicly and put to rest speculation. Mr. Mannion also stated he asked the Green Township Board of Education president about Mr. Nittolo and was told they would not speak about it due to the confidentiality of the issue. Mr. Mannion feels this is morally not right.

Tacia Johnson, of Coss Lane, stated that when she was president of the Montague Township School Board of Education, all members were given information right away in order to be able to have an informed vote. Information to the public was determined by law. Stated there was a BOE member who did not adhere to board ethics. Mrs. Johnson feels that Mr. Plotsky should step down as president of the BOE.

Dana Berry, of Durol Drive, on behalf of the Montague Township School PTA was donating a bench for the front of the school.

John Mannion, of Chubby Lane, claims the comment made by Mr. Teufert was insulting to the public. Also claims he was asked to run for BOE membership. Restated we don't have money.

Mr. Capone stated that for months Mr. Mannion and Mr. Eric Obernauer have been working together to create a story. Mr. Capone also stated firmly that the "Pass the Trash" laws do not allow hiring of individuals who would pose a risk to students. Mr. Capone stated that John Mannion and Eric Obernauer have failed to provide any facts to substantiate their claims. Mr. Capone explained that the school is in transition and the increase costs are caused by the High Point Regional High School excessively costly send / receive agreement, however budgets are always in flux. Mr. Capone said the district always addresses cost concerns. The district has added services and programs while also increasing savings. Mr. Capone informed the meeting that increasing the High School sending options will increase savings. Mr. Capone referenced an article by Mr. Eric Obernauer that had a major error in facts regarding our district, when in fact

we have streamlined our spending and improved our school. Mr. Capone asked the public to look at the actual facts.

Doris Mannion, of Chubby Lane, stated she asks questions but does not receive the answers she is looking for so instead relies on news articles. She stated she just wants answers.

John Mannion, of Chubby Lane, stated we have a \$300,000 position with no job description. He also stated there are limits to the townships money and the district is forcing people to move. He then offered to sell his house to Mr. Capone.

Hearing no further public comments, Mrs. Caramucci moved, seconded by Mr. Teufert to close public comment at 7:24 PM.
