#### VIII. CSA Report

- Mr. Capone received a request from Krista Mikulski who asked about the High Point Late run. Made a statement that a number of students ride that bus and concerned about the fiscal issues, that was discussed as a potential cost of savings. At her request, Mr. Capone/ team counted the number of students that ride that bus.
- Mr. Capone stated that \$16,000 is the total amount for that run, number of students that ride that bus daily are 2.6- less than 3 students a day on the late run bus.
- Paul Brislin asked for clarification about the calculation.
- Mr. Capone stated that students sign in daily to get on the bus from Fall June which equaled less than 3 students a day that ride the late bus.
- At the last meeting, Mr. Capone stated that 73% of Montague Township School at Highpoint has D's and F's. Mr. Capone asked the public is this a sign of success?
- July 24, 2017- Mr. Capone met with the Montague Parents for change where they voiced the concern that he was specifically hired to break the High Point agreement. He assured the group he supports choice, its never been an option to take off High Point as an option.
- From that meeting, he was given a list from Tasha DeGeorge with influential people in town where she made derogatory comments about certain people.
- Mr. Capone stated that the problem is heresay.
- He stated we should all be pro Montague. This group wants to provide fewer high school options that lead to fewer program options, with an increase in tuition which increases the burden on the taxpayers.
- He addressed the issue with communication that his team updates Facebook, twitter and the newspaper so they have accurate information on what is happening in the district instead of heresay that is not supported by facts.
- At the last meeting there was a number of votes that caused concern. Three years ago, when Mr. Capone started, the Board said it was a board of whole. Every board member has access to all information at the same time. All board members can freely participate in the discussion, voice concern at the same time that is done publicly. This is done so there is transparency as a board.
- Stated at the last meeting there was three members, without a discussion, voted not to renew all of our staff of 2020 2021.
- For transparency reasons, Mr. Capone asked for rationale on why we would not renew the staff.
  - They casted a vote no without a justification
  - Asked these board members, without bringing the staff back, how would the school be staffed for the school year 2020 2021.

Mr. Capone gave the board members the opportunity to share their reasoning behind voting No.

Dale Bouma

- Did not agree with services from the special needs vendor a we already have those services here therefore it is a waste of money.
- Part of their job is Ethics- protect the school personnel. Mr. Bouma stated they were never told anything else about the missing two staff members from the list except they were gone.

#### Paul Brislin

- Heresay of two people that were terminated that they found out they were terminated after the Board agenda came out.
- Heresay they were somewhat surprised to find out they weren't renewed.
- Paul Brislin felt that when an employer does that to an employee, it is inappropriate to let the person find out through the grapevine.
- Mr. Brislin stated that nothing was communicated to Paul publicly prior to that meeting that led him to believe these two employees would be terminated.
- For the record, Mr. Brislin stated he did not have any dissatisfaction with the teaching and administration staff. It was a vote consistent with the code of ethics and saw no other option in order to support the two people that were terminated.
- Mrs. Christmann will continue to support all the staff at the Montague School including those teachers reappointed and those teachers missing from that list. It was her understanding from the last meeting that there wasn't going to be any staff or programs cut.
- Mr. Plotsky stated Mrs. Christmann mentioned cut and Mr. Brislin mentioned terminated. He stated that it is not true to those individuals mentioned. They were not renewed. There is a difference.
- ➢ Mr. Capone's response
  - Mr. Capone stated he encouraged the board members to ask questions for information. Because they are not asking questions for information, they are making decisions on heresay.
  - Mr. Capone stated that this is a seven member board that because it is a whole of a board, the board gets the same information at the same time. The board gets the opportunity to have the same discussion at the same time. He understands there is a learning curve to coming onto a school board. This is the reason there was ethics training the first night they were on board along with an executive session bringing you up to speed with what is going on in the district. This is for transparency reasons for the board members. The public should have the same understanding as to what is each person's position was and what it is being decided and discussed.
    - At tonight's meeting, the last thing to cover, is the strategic plan which is from a timeframe standpoint
    - July 1- June 30. The Strategic plan was set by the board that was in place on July 1 and sets the goal, priorities, so they can execute over the course of the year.
    - In this strategic plan, the board accomplished what was set out to do and more.
    - Your job as new board members is finish out the year as far as goals were set.
    - Now setting objectives moving forward for student staff community moving forward into next year.

- Kathy Helewa- A board member's job is policy, budget, and setting goals along with measuring they are accomplished.
- The current Strategic plan that we are finishing out is facilities, replace tractor upgrades in the Perk bathrooms, PreK fencing, added new signage, 100% of this building used for classrooms, sealed the roof, and set up the agriculture classroom.
- Technology contract that will save us money, save 57K from 3 year period increase speed 5X as we have, new phone service.
- From a staffing perspective, last year added a full time speech therapist.
  - Provided APA training for pre k and paraprofessionals
  - Handle With Care, deescalate and restraint training
  - Instructional- replaced math curriculum, added financial literacy to Social Studies, institute standard based report cards in grade 3 and 4.
  - Professional Development Standpoint- made benchmark for our groups and for our students.
- Two items to be addressed communication where we get information on. Mr. Capone called out fake news on number of things reported, alleged mold, report back, no citation.
  - Eye wash station installed that was mandatory.
- There was a case of alleged assault promoted by the NJ Herald occurring, this case has been dismissed.
  - $\circ$  All cases brought by the people in the community have been dismissed.
- Mr. Capone stated it is important to look at what is the school district's focus and how the district is meeting the needs of the students and supporting the staff.
- Montague was selected last year to present at the NJ School Boards because of the positive changes.
- Mr. Capone is hopeful that with the creation of the new strategic plan and having these seven board members work collaboratively on what to accomplish; there will be success moving forward.
