> Discission

- Mr. Capone reiterates the loss of monies for the meal program. We did not opt in the program, based on the lack of participation from the families who do qualify for the meals that did not want to receive any meals over the course of the Spring when there was a shortage of food. We have never offered meals during the Summer; this would require additional staffing. Opting in this program the students that are on the free and reduced would not be able to get the meals delivered like they have been receiving. Last year we had more than five thousand dollars in deficit. Three years ago, it was twenty thousand dollars in debt for the meal program.
- Mr. Capone states this is not free to the district, when meals go unclaimed by families the districts loses money because we must pay for the unclaimed meals. Mr. Capone asked the board if we are going to continue delivering? or are we going to stop. Staffing comes in to play now if the board wants to continue the delivering. Then we must increase the time for the cafeteria staff, additionally we are going to need to hire another part time position for the cafeteria.
- Ms. Christmann suggested to send out a survey, asking if there would be an interest.
- Only four families have shown an interest, Mr. Capone stated the data we have does not support that there is a large interest, for the district to participate in this program.
- Mr. Plotsky discussed the different options the board can make before voting for this program.
