VIII. CSA Report

- Mr. Capone stated this is in reference to the budget, the funding formula is not the same as in 2012, if you lost 100 kids in 2012 you still received the same amount in funding. So last year, and this year, when we first established looking at the budget, we were looking at a long term plan over the last couple of years due to the fact that we knew we were going to be losing money and that this was significantly different and different because there used to be flat districts, if they lost students they didn't have a reduction in funding, The largest two aid cuts were this year and last year, that had been a priority as far as budgeting to ensure that we weren't looking at program cuts, or that we were going to lose things for students.
- Mr. Capone stated the preliminary budget needs to be approved to submit to the county office tonight because March 4th is the deadline.
- Mr. Capone stated the accomplishments that we went through over the last handful of years which has been posted on the school website to make sure that is available to the public. We have phenomenal teachers at Montague School, that work towards the best interest of our students. As for any other programs, there's been no discussions as far as things that this board would like to see for our students. There hasn't been anything identified as far as movement or any other priorities.

 - New Math curriculum for K-8th Grade (Bridges K-5th & CPM 6th-8th)
 - Financial Literacy inserted in SS Curriculum
 - Standards based report cards K-4th grades

 - Algebra 1 for the 8th grade students
 - Expansion of Kindergarten and Pre-K Services
 - Increased Intervention Services
 - Numerous Extracurricular programs
 - Professional Development/ monthly meetings
 - Child Study Team & Guidance Improvements
