7. CSA REPORT - John Nittolo, HIB half yearly/yearly report. From January through June there were 2 unfounded HIB reports. No HIB reports from the beginning of the year to December. - 8. SBA REPORT Carl Morelli Roof restoration project began last week. So far everything is going well and there have been no disturbances to classes. If there is anything it may be some smells in the air from products that are being used but there is nothing hazardous being used. We also completed a school safety assessment which was done in conjunction with the Sussex County Sheriff's Department and the NJ State Police and David Miller, our new FAcility Manager was in attendance too. Spent a good part of the day assessing the building inside and outside, doors, windows, any possibilities of anything regarding covering our school, building, land, students and staff. We are putting a plan in place and will be discussed with administration and NJ State Police and Sheriff's department. As reports come out they will be shared with the public and Board. We do have a lot of open land and do not want to take an opinion that nothing can ever happen because we live in a nice quiet part of the woods. Looking to have something within the month to have a complete report compiled and to present to the Board.
- 9. BOARD PRESIDENT'S REPORT Barbara Holstein Ms. Holstein attended the Sussex County Educational Service Commission meeting on June 6, 2022. Just learning about their services. They are a tuition base only so they can raise their budget. Would like to meet with Carl Morelli to discuss more of this and learn more about it during a whole board workshop. Their meeting was basically reappointing everyone and reappointing their budgets. They are also going to be adding a nurse bank to the services that they offer. Their cost was \$325.00 per day which is not the cost they would be charging to the District that would be more. We do have students attending there. A superintendent's report was given at the meeting regarding a roundtable meeting she had with parents. Eight out of the 10 parents who were in attendance at that meeting were wanting them to go back to normal operations. They want masks optional and go back to having outings. They are working hard to balance that concern within their population there. Will be attending next month's meeting too. Enjoyed our workshop meeting that we had.

Mr. Morelli thinks it was close to \$30,000 but doesn't have the information in front of him. It could be listed on our user-friendly budget under Audit Fees. Paul Brislin stated that the reason he was asking was because the prior CSA gave them a substantial increase due to the prior CSA blaming the former BA not doing their job adequately so the auditors had to allegedly spend a lot more time so the former CSA was quite generous in giving them a rather substantial increase at the time at taxpayer expense. Mr. Morelli stated that he has discussed with the auditors coming in on a quarterly basis at the same price instead of coming in at the end of the year and stated it is financially a prudent thing to do. Mr. Brislin stated that he believes the Municipality is also doing it on a quarterly basis which he believes is more efficient. Mr. Brislin asked Mr. Morelli if he has any thoughts on periodically soliciting RFPs to other audit firms to see if the \$31,500 fee is an appropriate fee to their competition. Mr. Morelli stated that from his experience we are certainly in the ballpark. It also depends on the type of audit they are doing for the District. If the District runs more efficiently and their billable hours are reduced then it keeps the yearly audit fee in line.

The \$31,500 is in the ballpark. Ms. Holstein asked if the \$31,500 is the maximum number for the year? Mr. Morelli stated that is correct and the only time it would go over is if we are hiring to do work over the audit. That would be a project by project basis and would need board resolution.

WHEREAS, the DEWA offers recreational opportunities such as hiking, walking, bicycling, fishing, hunting, swimming, camping canoeing, boating, cross country skiing, bird watching, horseback riding, sightseeing, and special events; cultural resources, infrastructural facilities, national resources and rare, threatened and endangered species of plants, fish, mammals, reptiles and amphibians; and

WHEREAS, the Montague School District is made up of Federally owned property and the residents of Montague enjoy the recreational opportunities as well as a cultural and natural resources of the open space and local businesses benefit from the tourism brought by State of New Jersey, Department of Environmental Protection, Division of Fish & Wildlife and DEWA bring to the Township; and

WHEREAS, the Montague School District is aware of a proposal by the New Jersey and Pennsylvania Chapters of the Sierra Club seeking to change the designation of the Delaware Water Gap National Recreation Area to the Delaware River National Park and Lenape Preserve; and

WHEREAS, is also undisputed that the authority to approve instruction materials is vested in the local Boards of Education;

WHEREAS, the Montague School Board intends to exercise its authority to approve instruction materials that are current, medically accurate, developmentally and age-appropriate, and developed and selected through meaningful and ongoing consultation with the school community, including parents;

THEREFORE, be it resolved, the Montague Board of Education shall NOT adopt any curriculum set forth by the New Jersey Student Learning Standards covered under the new Comprehensive Health & Physical Education 2020 NJSLS-CHPE that is not developmentally and age-appropriate, or that would result in subject matters including but not limited to oral sex, anal sex, masturbation, and gender identity being discussed with children at all grade levels.
