# **Open to Public (Any Items):**

As a reminder for all, and as per NJSBA, Board of Education meetings are "a meeting in public, not a meeting of the public. Many people especially parents and community members, misunderstand the nature of a school board meeting. School boards provide leadership for what are typically multi-million dollar corporations. The board has important work to accomplish. And, to do that work, the board needs to be fully engaged around the table. The Open Meetings Act requires that public business be done in public, and that citizens have opportunity to observe, and comment, at every meeting."

Additionally, as per NJSA 2C:33-8, 10:4-12, and as adopted by Montague's Board of Education in Bylaw 0167, please remember the public participation shall be governed by the following rules:

- 1. A participant must be recognized by the presiding officer and must preface by an announcement of his/her name, place of residence, and group affiliation if appropriate;
- 2. Each statement by a participant shall be limited to 3 minute duration
- 3. No participant may speak more than once on the same topic until all others who wish to speak on that topic have been heard;
- 4. All statements shall be directed to the presiding officer; no participant may address or question Board Members individually;
- 5. The presiding officer may:
- a. Interrupt, warn, or terminate a participant's statement when the statement is too lengthy, abusive, obscene, or irrelevant;
- b. Request any individual to leave the meeting when that person does not observe reasonable decorum;
- c. Request the assistance of law enforcement officers in the removal of a disorderly person when that person's conduct interferes with the orderly progress of the meeting;
- d. Call for a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action; and
- e. Waive these rules when necessary for the protection of privacy or the efficient administration of the Board's business.

During this portion of the meeting, the residents are invited to address the Board with any comments or concerns that may be in respect to the operation of their school.

Mrs. Jeskey: She is proud to be the MEA president. Thanked the Board of the Seventh grade curriculum. Request the Board approve sports programs. Challenged the Board to make a motion for sports.

Mrs. Bisl: She was sporting the new shirts. Testing scores are on the parent portal. Concerned that sports is not on the agenda again. A present Board member ran on the "sports" theme. PTA has purchased iPads, Chromebooks, Lockers. Feels there is selective transparency with this board. Possible ethics issue with our present attorneys.

Mrs. Mikulski: No one is commenting on the sports issues. Will the board pay for Port Jervis tuition? Board does not take interest in the students at Port Jervis. igh Point has a 94% graduation rate.

Ms. DeGeorge: Read a letter from her daughter Erica which stated there is nothing to look forward to.

Mrs. Campbell: Would like to have basketball continued this year.

<u>Mr. Derin</u>: Emphasize importance of sports for pre-teen students, it is invaluable. Why isn't the Commissioner's letter dated 9/2/15 on the website?

Mrs. Olenick: Student Handbook states no cell phones/devices are to be used in the school, but someone took pictures. Students need to have a way to state their concerns. Basketball should be considered past practice. Did the Board ever vote on sports? Alyssa wants to read the Principal's Principles, but it is for 7<sup>th</sup> graders.

Mrs. Spinapolice: Do not remember the parents questioning the sports program previously, but she did. How many juniors do we have at High Point?

Tacia stated they can do an OPRA request for this information.

Mr. Taylor: Handed out information on the benefits of sports programs for the board to review.

Mr. Mannion: Feels this Board is being more transparent to the public. The district will benefit from the law suits once we are victorious. Believes in sports and Port Jervis has sports.

<u>Mrs. Mikulski</u>: The sports program is tied to litigation. Why was the sibling rule rescinded, it was in place already? Sports were discussed and it is important.

Miss. Anni Bisl (student): Please bring back basketball.

Ms. DeGeorge: She took pictures of the bus evacuation with her cell phone to get pictures for the yearbook.

Ms. Blackburn: Her daughter is doing well and is happy in Port Jervis School. Why is High Point is questioning Montague students about transition? She would not want her child to drive over Deckertown

Turnpike.

Mr Mannion: Sports should not be withheld due to litigations. Bring us back to the way it was, rip up the High Point contract.

Ms. Holstein: The ethics violation of 7/28 dismissal was denied. The matter was found not to be frivolous and 7 of 11 sent to OAL

<u>Mr. Perez</u>: There were three ethics complaints on a current Board member; two have been dismissed. There have been no findings that anyone has acted unethical.

Mr. Mannion: If an unethical claim has not been filed, it does not mean one has not been committed.

Mrs. Olenick: Feels the Board is taking all public comments seriously. Past president said she did not answer emails.
