Liaison Updates

Mrs. Cole and Mrs. Johnson attended the last High Point board meeting, where the settlement was accepted. The board stated that it would consider the request regarding siblings. Mr. Kraemer advised that the terms of the settlement included in the consent order have been signed by Judge Marose and will go to the Commissioner of Education, who has 45 days to approve it. We expect to have approval. Superior Court and federal court issues are still pending.

Open to Public (Any Items):

As a reminder for all, and as per NJSBA, Board of Education meetings are "a meeting in public, not a meeting of the public. Many people especially parents and community members, misunderstand the nature of a school board meeting. School boards provide leadership for what are typically multi-million dollar corporations. The board has important work to accomplish. And, to do that work, the board needs to be fully engaged around the table. The Open Meetings Act requires that public business be done in public, and that citizens have opportunity to observe, and comment, at every meeting."

Additionally, as per NJSA 2C:33-8, 10:4-12, and as adopted by Montague's Board of Education in Bylaw 0167, please remember the public participation shall be governed by the following rules:

1. A participant must be recognized by the presiding officer and must preface - by an announcement of his/her name, place of residence, and group affiliation if appropriate;

2. Each statement by a participant shall be limited to 3 minute duration

3. No participant may speak more than once on the same topic until all others who wish to speak on that topic have been heard;

4. All statements shall be directed to the presiding officer; no participant may address or question Board Members individually;

5. The presiding officer may:

a. Interrupt, warn, or terminate a participant's statement when the statement is too lengthy, abusive, obscene, or irrelevant;

b. Request any individual to leave the meeting when that person does not observe reasonable decorum;

c. Request the assistance of law enforcement officers in the removal of a disorderly person when that person's conduct interferes with the orderly progress of the meeting;

d. Call for a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action; and

e. Waive these rules when necessary for the protection of privacy or the efficient administration of the Board's business.

During this portion of the meeting, the residents are invited to address the Board with any comments or concerns that may be in respect to the operation of their school.

Mr. Kraemer reported on the issue of policies and procedures. He stated that investigation shows that the district is in compliance with concussion, eye injury, and cardiac arrest policies.

Mr. Gregory, the Assistant Principal, responded to the board's Rice notice by submitting a letter requesting that all discussion relating to his position be discussed in public session.

Ms. Johnson – The board has requested information so that they can make informed decisions

Mr. Gregory did not provide information for the sports program, which caused delay. This put the board in a bad light.

Information given to the state by Mr. Gregory included old policies that shouldn't have been included Mr. Gregory has intimidated the board into agreeing to, and approving, things

Mr. Gregory seems to be in opposition to the board

We still don't have what we asked for

We can't make decisions without information

Mrs. Masset – A mother approached her about the sports program

- Believes that there wasn't enough done by Mr. Gregory
- Mr. Gregory's talents are not taken advantage of
- Believes that we don't need a full-time Assistant Principal who doesn't teach; it is wasted money There's not enough work
- He is supervising the cafeteria for large amounts of money
- His time should be better utilized
- We are paying way too much money for what we receive

Diane Cole – Because of all of the costs, shared services should be looked into

Ms. Johnson – Mr. Gregory has shown outward defiance. He said, "If I give this to you, you're not even going to approve it," when talking about the sports program
Mr. Gregory suggested volleyball for Montague. Our sports should mirror what High Point has. At High Point, volleyball is only intramural/recreational, not a varsity sport. Board said that he should try to set kids up prepared for High School program
Mrs. Masset – We have to look at his position and give him more obligations
In two weeks his contract is up; it should be replaced or modified
This school system does not justify his position for the amount that we pay
Negotiations should start now; Mrs. Hodge should be involved to give testimony
We are talking about a very high salary
A teacher that we have just might be able to do the duty of the Vice Principal or could work towards it.
Mrs. Johnson – We have choices, to not renew, to renew with changes and modifications
Mr. Kraemer – That's part of negotiations, you should start now
Mrs. Andriac – We will be looking for a Spanish teacher?

Mrs. Masset - We are talking about a very high salary and someone who doesn't have enough obligations

Mrs. Johnson – We will have a Personnel Committee meeting

Mr. Plotsky – We should have a Personnel Committee meeting

Ms. Johnson - Direct Jan MacKenzie to email to Gary Kraemer a copy of Chris's contract
