Tracy Dickson also asked if there will be a permanently assigned bus driver for her children's route; different bus driver every day.

*Note:* The Assistant Principal reported that while parked in front of the school, the driver engaged the emergency brake and exited the bus. The emergency brake, however, did not hold and the bus rolled back several feet before the driver could get back in the bus and stop it. The bus was inspected to ensure safety and the driver received additional training.
